CALL TO ORDER

Mayor Peoples called the meeting to order and asked for a moment of silence. Commissioner Ingham led the Pledge of Allegiance.

AGENDA ADOPTION

Mayor Peoples added item 12a. Closed Session to discuss personnel and asked if there were any other additions, deletions or corrections. Being none, he entertained a motion to adopt. Commissioner Armbrust so moved. The motion carried unanimously.

CONSENT AGENDA ADOPTION

Mayor Peoples asked if there were any additions, deletions or corrections. Being none, he entertained a motion to adopt the Consent Agenda which included the Board minutes and financial report. Commissioner Ingham so moved. The motion carried unanimously.

PUBLIC HEARING: TEXT AMENDMENT TO MODIFY HEIGHT RESTRICTIONS FOR ADJACENT FRONT, SIDE & REAR YARDS

Mayor Peoples opened the public hearing. Planning Director Daniels reported he had received inquiries concerning the height of fences on property lines. They have drafted new guidelines to give property owners a little more privacy. His board has approved and ask for the Board's consideration. Joyce Kimpton asked for the text amendment to be read. Daniels read the amendment. It is basically changing the maximum height from four feet, when adjacent to a street or front yard and eight feet when adjacent to a side or rear yard. Being no other comments, Mayor Peoples closed the public hearing. Commissioner Ingham made a motion to adopt the text amendment modifying the height restrictions. The motion carried unanimously.

REQUEST FOR QUALIFICATIONS FOR ON-CALL ENGINEERING SERVICES

Town Manager Ollis reported the on-call engineering services is a proposal from WithersRavanel. This will keep us in line with some of the regulations. You can still go through the RFP Process if you wanted to. This is a three-year agreement and either party can get out of the contract. This will help with emergency situations. Commissioner Armbrust asked if there is a binder fee. Ollis replied no. This will

streamline projects. Commissioner Armbrust made a motion to accept the proposal from WithersRavanel. The motion carried unanimously.

MINIMUM HOUSING

Planning Director Daniels reported:

- 1. 45 Canady Lane scheduled to burn tomorrow or Thursday.
- 2. 136 Cleveland waiting on asbestos results to get burn at the request of the owner.
- 3. 144 Cleveland inspected, he has reached to owner and they are going to try to coordinate the asbestos testing so that they can burn them at the same time.
- 4. 160 Cleveland met with the Eastside Committee and he has multiple complaints. The owner also owns 144 Cleveland.
- 5. 161 Peake inspection is scheduled tomorrow at 9:00 a.m.
